# 4) Installation of launching ramp by the Festival du Doré Baie-James

Ref. No.: 3214-04-035

The Evaluating Committee (COMEV) received the preliminary information as well as additional information on the above project on August 28, 2018.

The Festival du Doré Baie-James plans to renovate the launch ramp at the municipal pier located at Lake Opemisca. This ramp, which is used by tourists and vacationers, has deteriorated and presents a breakage risk for users' vehicles. The objectives of the project are a) to renovate the launch ramp, b) to have a ramp that is safe and conforms the standards for the boats and c) to allow for better attachment of the new wharf, which has been in place for two years.

After reviewing the documents sent by the proponent, the COMEV decided to recommend that the project be exempted from the assessment process.

Action: Send a letter to the Provincial Administrator recommending that the project be exempted from the assessment process.

5) Installation and operation of a mobile concrete plant in the Waswanipi sector by Pavex Ltd.

The Evaluating Committee (COMEV) received the preliminary information on the above project on August 28, 2018. Additional information arrived on September 11. 2018.

Pavex Ltd. plans to install and operate a mobile concrete plant in an existing sandpit in order to carry out maintenance and improvements to Route 113.

After reviewing the documents from the proponent, the COMEV decided to recommend that the project be exempted from the assessment process.

The COMEV understands that the certificate attesting the conformity of the work and the supporting documentation, issued by the Eeyou Istchee James Bay government, will be sent to the Administrator as soon as possible. The COMEV also understands that the equipment usually required in the event of a spill will be readily available on site, if necessary.

Action: Send a letter to the Provincial Administrator recommending that the project be exempted from the assessment process.

6) Stripping of 12 overburden areas at the Sirmac site by Vision Lithium inc.

The Evaluating Committee (COMEV) received the preliminary information on the above project on October 11, 2018.

Vision Lithium Inc. would like to carry out stripping work, as part of preliminary exploration work at the Sirmac site. This work should provide more detail on the geology in the sector. Such knowledge will be used to guide future mining exploration work in the area.

After reviewing the document provided, COMEV would like to ensure that the proponent has been informed the relevant tallyman(men) about the project. The proponent will need to inform the Administrator on this, and in particular about any concerns that were expressed. Once the COMEV has this information, it can complete the analysis of this file.
