1) Meeting declared open and adoption of the agenda

2) Adoption of the minutes of the 289th meeting

On October 2, 2019 the Evaluating Committee (COMEV) received the preliminary information on a project to rehabilitate the launch ramp on Waswanipi Lake in Eeyou Istchee James Bay Regional Government territory.

After discussion, members determined that the proponent had not included any information related to consultations with the Cree community of Waswanipi in the preliminary information. The COMEV is therefore waiting to receive this information before it can continue its analysis of the project.

5) Waswanipi Lake launch ramp rehabilitation project in the territory of the Eeyou Istchee James Bay Regional Government

On October 2, 2019 the Evaluating Committee (COMEV) received the preliminary information on a project to rehabilitate the launch ramp on Waswanipi Lake in Eeyou Istchee James Bay Regional Government territory. Additional information was sent on October 25, 2019.

In this project, the Eeyou Istchee James Bay Regional Government wishes to rehabilitate the launch ramp at Waswanipi Lake. The rehabilitation is planned in two phases: 1) remove the broken concrete slabs to replace them with new slabs of the same size and 2) extend and widen the current launching ramp.

The COMEV encourages the proponent to keep the communication channel open with the community of Waswanipi regarding the work to be carried out.

After reviewing the documents sent by the proponent, the members of the COMEV decided to recommend that the project be exempted from the review process.

Action: Send a letter to the Provincial Administrator recommending that the project be exempted from the review process.

6) New landfill in Wemindji project

- Preliminary information
 - For recommendation on whether to exempt the project from the assessment process or on the scope of the impact study to be conducted

On August 26, 2019 the Evaluating Committee (COMEV) received the preliminary information on a project from the Cree Nation of Wemindji to develop a new landfill in Wemindji.

The purpose of this project is to build a landfill for waste materials in Wemindji. Given that there was fire destruction at the incinerator in the fall of 2018 and the fact that the existing landfill, which had an estimated 10-year life span, will be full by the fall of 2020, the construction of a new landfill is a priority for the community. Although the community plans to replace the incinerator with a new facility by 2021, the community will still need to build a new landfill before winter of 2020.

Members of the COMEV were presented with a draft directive and made some modifications before agreeing that the directive could be forwarded to the Regional Administrator.

Action: Send the impact study directive to the Regional Administrator.
