1) Eastmain-1-A and Rupert diversion hydroelectric project – Permanent residential complex on the site of the Eastmain-1 temporary camp by Hydro-Québec Ref. No.: 3214-10-017

Representatives of Hydro-Québec (Natalie Nicole and Luc Duquette), the James Bay Energy Corporation – SEBJ (Nourredine Mouncef), the Nadostin Residence Corporation (Davey Bobbish) and the Cree First Nation of Eastmain (Greg Williams) presented a brief description of the project for a permanent residential complex on the Eastmain-1 workcamp site. The project will include a new residential building, a community center and the updating of existing infrastructure. They also presented a summary review of the application for exemption that the proponent, the Corporation Résidence Nadoshtin, plans to file in May of 2022.

Hydro-Québec will be the sole user of the new residential complex, which will accommodate up to 100 people. Hydro-Québec will retain a right to monitor any installation on the periphery of the complex.

5) Expansion of borrow pit GD-17 at Nemaska by the Cree First Nation of Nemaska Ref. No.: 3214-03-046

On June 16, 2021, the Evaluating Committee (COMEV) received preliminary information regarding the borrow pit project in Nemaska. Additional information (responses to questions and comments) was received February 16, 2022.

The proponent wishes to enlarge an existing borrow pit as the existing pit is located close to the village and has existing road access to and from the village. The expansion would meet the short- and medium-term sand and gravel needs of the Nemaska community for road construction and municipal works.

After reviewing the documents from the proponent, the COMEV recommends that this project be exempted from the social and environmental impacts assessment process.

The COMEV suggested that before starting the excavation work, the proponent check for the presence of avian species, such as the bank swallows, that may be nesting in the gravel/sand, and contact the Ministère des Forêts, de la Faune et des Parcs to find out about methods for protecting these species.

6) Opening and operation of a quarry in the Chibougamau sector by Dynamitage TCG inc.

On February 21, 2022, the Evaluating Committee (COMEV) the preliminary information concerning the opening and operation of a quarry by a Dynamitage TCG Inc.

The proponent would like to open a quarry of fewer than 3 hectares to extract granular materials that will be used to manufacture concrete, bitumen and ballast for construction needs in the region. Surface mineral processing will include crushing, drilling, and blasting. The proponent indicated that access to the quarry will be provided via an existing road and that developing the quarry will require the deforestation of the extraction area. There are also plans to build areas for stockpiles and material storage as well as construction trailers about 500 meters from the quarry.

After reviewing the documents from the proponent, the members of the COMEV agreed that additional information is required before continuing their analysis. The proponent will be sent a letter with a request for responses to various questions and comments.

Rehabilitation of two sites on the Mid-Canada radar surveillance line by the Ministère de l'Environnement et de la Lutte contre les Changements Climatiques

On February 22, 2022, the Evaluating Committee (COMEV) received the first information about a project to rehabilitate a site on the Mid-Canada line from the MELCC. On April 25, the COMEV received more information concerning the addition of a second site to the application for exemption.

The MELCC's environmental liability department would like to undertake with the rehabilitation of sites 403A and 406A of the Mid-Canada radar surveillance line. The Mid-Canada Line was built in the 1950s at the 55th parallel and was abandoned in 1965. Many of the 45 sites along the radar surveillance line have never been rehabilitated and old infrastructure and equipment, such as empty fuel drums, are still present. These sites are contributing to the deterioration of environmental quality and pose a risk to the health and safety of territorial users. The planned rehabilitation work includes the removal of residual hazardous materials, the dismantling of infrastructure and the removal of existing equipment, as well as the removal of contaminated soil. Dismantled materials and contaminated soils will be transported to authorized storage or treatment sites. If ground transport is required, it would be carried out during the winter period. The rehabilitation work should be carried out in the spring or summer of 2023.

After reviewing the documents from the proponent, the COMEV recommends that this project be exempted from the social and environmental impacts assessment process.

The COMEV encourages the proponent to maintain open channels of communication with the recipients and the local authorities responsible for the management of the residual hazardous materials, dismantled materials, and contaminated soils.
