### 4) Dismantling of the main camp and satellite camps of a former outfitter in the Trans-Taïga Highway sector by the MERN

The Evaluating Committee (COMEV) received the preliminary information on the above project on April28, 2022. Additional information (responses to questions and comments) was received August 8, 2022.

In this project, the MERN plans to clean up the abandoned sites at the main camp and seven satellite camps once used for the Nouchimi outfitter operation along the Trans-Taïga road. The work includes the demolition of buildings and facilities on the sites, the recovery, segregation, recycling and disposal of various residual materials and equipment, the management and disposal of residual hazardous materials as well as the restoration of land (filling, leveling and revegetation). Reusable materials and equipment will be donated to neighboring communities. Recoverable residual materials will be segregated and sent to an authorized sorting center and all other non-recoverable residual materials will be disposed of in an authorized technical landfill (LET).

After reviewing the documents submitted by the proponent, the COMEV recommends exempting this project from the environmental and social impact assessment and review procedure.

The COMEV will encourage the proponent to consult again with the tallymen regarding land restoration (backfilling, leveling and revegetation) to approve the revegetation plan (mixture of predominantly native seeds). COMEV will also remind the proponent of the importance of maintaining open communications with the Chisasibi community throughout the project.

### 5) Construction of the Nadoshtin Residence by the Société Corporation Résidence Nadoshtin Inc.

The Evaluating Committee (COMEV) received the preliminary information on the above project on July 11, 2022.

On November 24, 2006, the MELCC issued a certificate of authorization to Hydro-Québec for the Eastmain-1-A powerhouse and Rupert diversion project, which provided for the construction of a temporary camp for workers during construction. The proponent, Corporation Résidence Nadoshtin, would like to build a permanent residence on the site of the Eastmain-1 workcamp. The original Hydro-Québec camp was designed to house up to 2,000 workers and was gradually dismantled between 2011 to 2015. The proponent would like to modify the camp to meet Hydro-Québec's current needs. Of the 50 buildings making up the camp, 18 will be kept in operation and 31 will be dismantled. Two buildings will be built or refurbished, namely the residence (~100 rooms) and the sports and community center. Outdoor facilities will also have to be adapted to the new layout. This will include modifying roadways, construction of parking lots and the installation of new landscaping, such as pedestrian paths, lighting, tables, benches, and garbage cans.

After reviewing the documents sent by the proponent, the COMEV decided that additional information is necessary before it can continue its analysis. Thus, the proponent will be asked to answer questions and comments, which will be included in a transmission letter.
