On December 7, 2023, the Evaluating Committee received the preliminary information on the above mining project.

The Corvette Mine Project is located 250 km east of the community of Radisson, on Category III land. The project is also located on the common boundaries of three Cree communities: Chisasibi (330 km to the west), Wemindji (330 km to the southwest) and Mistissini (350 km to the south). The project involves the exploitation of an open pit spodumene (lithium) pegmatite deposit for an estimated lifespan of 23 years. The mine complex will consist of a variety of infrastructure, including an access road to the mine site from the Transtaïga Highway, a worker camp, waste rock, tailings and ore storage areas, an ore processing plant, and a water treatment plant.

After reviewing all the information submitted by the proponent, the COMEV will send to the Provincial Administrator, in the form of a directive attached to its letter of transmittal, its recommendation on the scope of the environmental and social impact assessment to be carried out by the proponent.
