The Evaluating Committee (COMEV) received the preliminary information on the above project on August 6, 2020 and additional information on September 29, 2020. On November 23, 2020, the COMEV received a letter from the MELCC confirming that the proponent had sent a request to withdraw the application for exemption as well as confirmation that, considering new information, the MELCC had determined that the project as described was automatically exempt from the review process. Thus, the COMEV is not required to make a recommendation on this project.

The Evaluating Committee (COMEV) received the preliminary information on the above project on August 6, and additional information on September 29, 2020. On November 23, 2020, the COMEV received a letter from the MELCC confirming that the proponent had sent a request to withdraw the application for exemption as well as confirmation that, considering new information, the MELCC had determined that the project as described was automatically exempt from the review process. Thus, the COMEV is not required to make a recommendation on this project.

6) Operation of a quarry and hot mix asphalt plant at km 393.9 of the James Bay Highway by the James Bay Energy Corporation

On September 14, 2020, the Evaluating Committee (COMEV) received preliminary information on the above quarry project at km 393.9 of the James Bay Highway.

In this project, the James Bay Energy Corporation wants to operate a quarry of less than 3 hectares and a hot mix asphalt plant at km 393.9 of Billy-Diamond Highway (formerly the James Bay Highway). The purpose is to provide materials for repairs to Billy-Diamond Highway.

After reviewing the documents from the proponent, members decided to recommend that the project be exempted from the review process.

- 7) Quarry greater than 3 ha near the La Grande-3 hydroelectric complex by Hydro-Québec Ref. No.: 3214-03-045
 - a) Preliminary information
 - For recommendation on the scope of the impact study to be conducted

On October 2, 2020, the Evaluating Committee (COMEV) received the preliminary information from Hydro-Quebec regarding a quarry project near its La Grande-3 complex.

Hydro-Québec's intention is to develop and operate a quarry to produce crushed gravel in the La Grande-3 hydroelectric sector. The project would involve the development of a quarry of about 5 ha that would include an extraction area, a stacking area, an equipment storage area and a crushing and screening area.

The proponent will first have to clear trees and brush, then remove the topsoil. The granular materials produced will be used, among other purposes, for the maintenance and repair of various Hydro-Québec infrastructures and facilities located in the LG3 sector, such as roads, bridges, and culverts, as well as certain buildings.

Members reviewed a draft directive and made some changes before agreeing that the directive can be sent to the Provincial Administrator.

8) Underground exploration ramp, underground drilling, and bulk sampling in Sector 51 of the Fenelon project by Wallbridge Mining Company Limited Ref. No.: 3214-14-064

On October 22, 2020, the Evaluating Committee (COMEV) received the preliminary information on the above project in Sector 51 of Wallbridge Mining's Fenelon project. Additional information was received on December 22, 2020.

According to their proposal, Wallbridge Mining Company would like to undertake, in tandem with its surface exploration program, some underground development work, underground drilling and bulk sampling of 25,000 tonnes, mainly in Sector 51.

Given the new information received about this project, the COMEV convened extraordinary meetings on December 17 and 22, 2020 to continue its analysis of the project.

After reviewing the documents sent by the proponent, members concluded that they needed additional information before continuing their analysis and formulated a few questions and comments for the proponent.

- 9) Update on the bulk sampling program at the Windfall site by Osisko Mining Ref. No.: 3214-14-059
 - a) Preliminary information
 - For recommendation on whether to exempt the project from the review procedure, or on the scope of the impact study to be conducted

On November 27, 2020, the Evaluating Committee (COMEV) received from Osisko the preliminary information regarding an update to the bulk sampling work at the Windfall project.

The purpose of this new sampling work is to develop a better understanding of the indicated resources to include in its feasibility study. The rationale stated in the company's previous requests for bulk sampling work remains the same – ie, to understand the unique geology at Windfall, as well as the mineralization complexity and the nugget effect. The objectives of the new bulk sampling are to reveal the various styles of mineralization in different host rocks, evaluate representative zones with average grades from the 2020 resource estimates, characterize the various controls affecting the zones (thickness, verticality, continuity) and reconcile the grade levels with the resource estimates (without processing).

After reviewing the documents from the proponent, the COMEV decided to recommend that the project be exempted from the review process.
